Waiver and Release from Liability

I acknowledge and understand that there are risks of personal injury involved in this activity for which I have agreed to take complete responsibility. I have also been briefed about the dangers and risk involved and safety precautions and rules I am advised to follow to minimize the chance of injury. I agree to follow the below listed rules.

- 1) I acknowledge and fully understand that I will be engaging in activities that involve risk of serious injury, which may include permanent disability and even death, and severe social and economic losses which might result not only from my actions, but also from the action, inaction, of others, the rules of Expedition/Rides / Event, or the condition of the premises, and further that there may be risks not known to me or not reasonably foreseeable. I expressly assume all risks of injury, including death, which may occur in connection with my participation in activities at The Company.
- 2) I agree to assume all the foregoing risks and accept full responsibility for my own damages following such injury, permanent disability, or death.
- 3) I release, waive, discharge, and agree not to sue The Company, and any subsidiaries and all its respective agents, affiliates, associates, officers, directors, owners and employees (collectively "Releasees") from demands, losses, or damages on account of any bodily injury, death or property damage caused or alleged to be caused in whole or in part by Releasees or any other party's actions, inactions, or otherwise. I also agree to indemnify Releasees from any and all third party claims caused in whole or in part by other individuals or entities as a result of my actions.
- 4) I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as The Company may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.

- 5) I expressly agree that the terms of release and indemnity contained herein are intended to be as broad and inclusive as is permitted by the laws of this state. Any provision or portion of this Waiver, Release, and Indemnity Agreement found to be invalid by the courts having jurisdiction shall be invalid only with respect to such provision or portion.
The offending provision or portion shall be construed to the maximum extent possible to confer upon the parties the benefits intended thereby. Said provision or portion, as well as the remaining provisions or portion hereof, shall be construed and enforced to the same effect as if such offending provision or portion thereof had not been contained herein.
- 6) I agree to give all other vehicles the right of way and conduct myself in a safe manner. I understand that the use of a hard-shell riding helmet is required for this event. As the event may require riding in low-visibility conditions (such as darkness, fog, rain, tunnels etc), I will at all times be equipped with and deploy a strong front light, red rear lights and reflective vests or tapes.
- 7) I understand that portions of the route are along busy roads/highways. So, I will obey all safety regulations for bicycles travelling on busy roadways, and will be governed by all the local laws, including traffic laws.
- 8) I take full responsibility for my own safety during the period of COVID-19 pandemic or novel coronavirus and assume all the risks of participating in this event and I waive, release and forever discharge Dare2Gear, its constituents and its assigned associates from any and all liability for my death, myself contracting infection, spreading infection to others, hospitalization and any financial expenditures thereof.
- 9) I will take all safety precautions of carrying & wearing mask, carrying & using hand sanitizer, maintaining social distancing and following all guidelines issued by local, state & central authorities including Ministry of Home Affairs.
- 10) I understand that only basic first aid may be available to participants on the event route, provided the official vehicle is close at hand. Should I require additional medical attention, I hereby consent to receive such medical treatment which may be deemed advisable during the event, and understand that I am solely responsible for all costs and consequences relating to medical administration, evacuation and transportation.
- 11) Assure that I am in proper and good health and I am physically fit to participate in this event. I am not suffering from any disease, which might remotely either put myself or the other participants to any risk or danger.
